Donovan has been a Senior Fellow at the Center for Community Investment and is a current Fellow at the Beeck Center for Social Impact + Innovation at Georgetown University. An influential thought leader, Donovan has published numerous papers and articles on topics related to building ecosystems, infrastructure and access to economic opportunity and equity.
